DEREGISTRATION OF SECURITIES

This Post-Effective Amendment (the "Post-Effective Amendment") relates to the Registration Statement on Form S-8 (Registration No. 333-131157) filed by QUALCOMM Incorporated (the "Company") with the U.S. Securities and Exchange Commission on January 20, 2006 (the "Registration Statement") to register 483,123 shares of the Company's common stock, par value \$0.0001 per share, for issuance under the Options to purchase common stock granted under the Berkana Wireless Inc. 2001 Stock Incentive Plan, 2002 Stock Plan and 2002 Executive Stock Plan assumed by QUALCOMM Incorporated (collectively, the "Plan"). As of the date of this Post-Effective Amendment, the Plan has terminated, no awards remain outstanding under the Plan, and no additional Shares will be issued under the Plan.
